## Data Use and Privacy Policy

Date of Last Revision: **August 10, 2018**

Gath3r.io, Inc. ("**Gath3r.io**", "**we**", "**our**", "**us**") respects your privacy and is committed to protecting your Personal Information and being transparent about how we collect, use, and share your Personal Information. This Privacy Policy ("**Policy**") applies to your use of our blockchain platform ("**Platform**"), and web-based mining operations ("**Operations**") as well as email group services, your browsing of this website located at [www.Gath3r.io](http://www.Gath3r.io) or to any website that includes a link or reference to this Policy ("**Website**") and to your use of our mobile applications and related services (all of the above are collectively, the "**Services**"). This Policy describes how we handle Personal Information (as described below) and the choices available to you regarding collection, use, access and how to update and correct your Personal Information.

### Personal Information we collect

We collect data, including Personal Information that you provide on our Services and as you use the Services. "Personal Information" includes information that can be used to identify you as a natural person, directly or indirectly, in particular in combination with other information available to us such as an identification number, online identifier or one or more factors specific to your identity as a natural person and may include your:

- Name;
- citizenship information;
- e-mail address;
- data about your use of the Services;
- cryptocurrency wallet address, etc.

Each visitor to and user of the Services may be identified by cookies or similar technologies (see our [Cookie Policy](#)) as well as by an IP address during their visit. The information we collect depends on how you use our Services. As the case may be, we may also collect information indirectly through Social Networking Services (as defined below) you would be using in connection with the Services.

If you fail to provide certain Personal Information when requested, we may not be able to perform the contract we have entered into with you (such as providing the Services to you), or we may be prevented from complying with our legal obligations.

## How we use your Personal Information

We only collect, use, and store your Personal Information for the purposes of operating our business and Services, delivering, providing, improving, and customizing our Services, sending other communications related to our business and Services, and for providing you with information, products, and services that you request from us. Gath3r.io collects Personal Information for a variety of purposes, including the following:

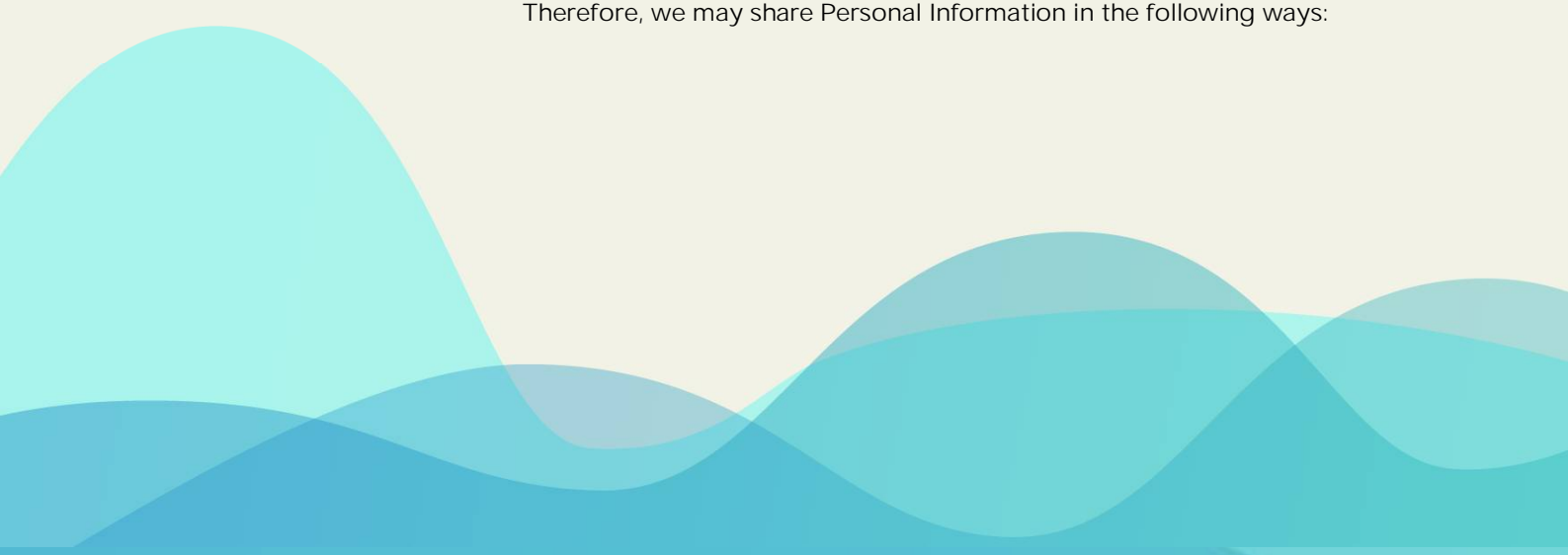
- Performance of a contract to which Gath3r.io is a Party, including subscribing to our Services;

- Improving the operation of the Services and/or help adjust the content of the Services to the general geographic location of you and for reporting purposes.

Where required or permitted by applicable law, we also use or disclose your Personal Information to limited third parties when we believe, in good faith, that such use or disclosure is reasonably necessary to (i) comply with the legal obligation bearing on Gath3r.io, (ii) enforce or apply the terms of any agreement to which we are a party, or (iii) protect the rights, property or safety of Gath3r.io, Gath3r.io's clients, or others.

## How we share your Personal Information

We may share your personal Information with our affiliate entities and other third-party business partners, providers, vendors or contractors acting on our behalf and under our instructions, whether located inside and outside of the European Union ("EU") or the Economic Area ("EEA"), for the purposes of operating our business, delivering, improving, and customizing our Services, sending communications related to our business and Services, and when needed, with your consent.

Therefore, we may share Personal Information in the following ways:

- Within Gath3r.io and any of our affiliate entities located inside or outside of the EU/EEA, for purposes of data processing or storage;
- With Gath3r.io's business partners, vendors, authorized third-party agents or contractors to provide our products and services or facilitate transactions. Examples include, but are not limited to: processing of orders, hosting websites and providing support.
- In connection with, or during negotiations of, any merger, sale of company assets, consolidation or restructuring, financing, or acquisition of all or a portion of our business by another company;
- As the case may be, for further protection of your privacy, Gath3r.io will share your Personal Information in aggregated and/or de-identified form that cannot be used to identify you.

Where mandated or permitted by applicable law, regulation or legal process, we will disclose your Personal Information to law enforcement officials, government authorities or other third parties, located inside and outside of the EU/EEA, where such disclosure is in accordance with due process of law and binding upon Gath3r.io, to the extent necessary to comply with legal process or meet national security requirements, protect the rights, property, or safety of Gath3r.io, its business partners, you, or others.

### **Transfer, processing and storage of Personal Information**

We may transfer your Personal Information to any Gath3r.io affiliate entity worldwide or to third-party business partners, providers, vendors, or contractors, that are located inside or outside of the EU/EEA, for purposes described in the section "How we share your Personal Information" above, including for the purpose of data processing or storage on behalf and under the control of Gath3r.io.

Gath3r.io implements cross-borders transfers in compliance with applicable privacy and data protection regulations, including Regulation (EU) 2016/679 of 27 April 2016 on the protection of personal data ("**GDPR**"). Where mandated by applicable law, to ensure that your Personal Information does receive an adequate level of protection, Gath3r.io implements the appropriate measures to ensure that your Personal Information is treated across Gath3r.io affiliated entities and by the aforementioned third parties in a way that is consistent with and which respects the applicable privacy and data protection laws. ### **Data Use**

The Platform provides services for its clients, these services allow for the client's website(s) to use website visitor's spare CPU and GPU power. This may lead to gathering information from those visitor's computers. We require our clients to have an opt-in or opt-out option on their site that allows people to not allow their computers to be used this way, and to notify them that their site has the Gath3r.io system in place for web-based cryptocurrency mining.

### **Links to third-parties' websites**

The Services may contain links to third-party websites that are operated by companies outside of our control. Your activities on those third-party websites will be solely governed by the privacy policies and procedures of those third parties. Gath3r.io takes no responsibility whatsoever for the content or information practices of such third parties and encourage you to review the privacy policies of these third parties before disclosing any information on their websites.
